eligibility

Open to all artists and photographers who reside in San Diego County.

entry fees

Each artist may submit up to five images. The fees for members of the LJAA are \$25 for the first image and \$10 for each additional image. For non-members, the fee for the first image is \$30 and \$10 for each additional image.

juror decisions

Artists will be notified by email of the juror's decisions by July 29, 2006.

exhibition hours

Monday, August 14th through Sunday, August 27th from 11am to 5pm every day including holidays.

Artist's sales will be processed through the La Jolla Art Association and a 25% commission will be charged on all work sold. Selling artists will receive payment 30 days after the close of the exhibition.

LJAA Members accepted for this show must commit to staffing the gallery or performing another volunteer service.

liability

The utmost care will be taken of your art. However, the La Jolla Art Association, its officers and members assume no responsibility for damage, theft or loss to art entered. Insurance is the responsibility of each artist.

digital submissions only

1. Images must be RGB or Grayscale JPEG files sized at 72 dpi and **NO LARGER** than 10 inches on a side. All files must be smaller than 1MB.
2. Do not submit information on the image.
3. Submit files on a CD ONLY. CDs will not be returned.
4. Submit a separate text (.txt) file containing:
 - a. Artist's name
 - b. Artist's complete address
 - c. Artist's phone number
 - d. Artist's email address
 - e. Title
 - f. Frame size (W x H) with a maximum size of 36" on any one side.
 - g. Price — All works must be for sale

All forms of photography are welcome with the exception of images that require use of electricity or electronics.

Accepted works must be delivered **IN PERSON**, **UNLESS** prior arrangements are made.

Shipping, if arranged in advance, and any insurance, are the responsibility of the artist.

Artists agree that submitted images may be used for advertising La Jolla Art Association events.
